## **TERMS & CONDITIONS**

#### 1. The Promoter

The promoter is ExxonMobil Guyana Limited of 99 New Market Street, Georgetown, Guyana (the "**Promoter**").

### 2. The competition

- 2.1 There are 100 VIP passes for Stinging Nettles, and for Baderation, 100 General, 100 VIP, and 15 VVIP passes to be won for the duration of the competition.
- 2.2 To enter, please complete and submit the online entry form on the website here: [www.exxonmobil.com/guyanacontest ].

### 3. How to enter

- 3.1 The competition will run from April 7 to May 20, 2025 inclusive (the "Competition Period").
- 3.2 To enter the competition, complete and submit the online entry form by the end of the Competition Period.
- 3.3 Only one entry is required to participate. On submitting your entry, you will be entered into the prize draw.
- 3.4 The prize draw is free to enter and no purchase is necessary.
- 3.5 The Promoter will not accept:
  - (a) responsibility for competition entries that are submitted incorrectly, lost, corrupted, or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
  - (b) proof of submission online as proof of receipt of entry to the competition.
- 3.6 If you subscribe to marketing emails as part of entering the competition, you can subsequently unsubscribe at any time by following the instructions given in the accompanying emails. Signing up to marketing emails is optional and not part of the competition. Signing up does not result in any advantage or disadvantage to a participant.
- 3.7 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.

### 4. Eligibility

- 4.1 The competition is open only to all residents in the Co-operative Republic of Guyana aged 18 years or over, **except**:
  - (a) employees of the Promoter or the Organiser or their affiliated companies;
  - (b) employees of agents or suppliers of the Promoter or Organiser or their holding or subsidiary companies, who are professionally connected with the competition or its administration;
  - (c) members of the immediate families or households of (a) and (b) above;
  - (d) any employee or official of any government, or government-owned or government-controlled entity, that has regulatory authority over ExxonMobil Guyana Limited.

- 4.2 In entering the competition, you confirm that you are eligible to do so and eligible to claim the prize. The Promoter may require you to provide proof that you are eligible to claim prize.
- 4.3 Only one entry to the competition is permitted per person throughout the Competition Period. Second or subsequent entries with the same e-mail address, and/or phone number and/or name will be disqualified.
- 4.4 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.

## 5. The prizes

- 5.1 The main prize for Stinging Nettles is 1 VIP ticket per winner, while Baderation offers 4 VVIP tickets for first prize, 3 VVIP tickets for second prize, 2 VVIP tickets for third prize, and other consolation prizes of either 1 VIP ticket or 2 general tickets per winner.
- 5.2 Participants are limited to winning a maximum of one prize throughout the Competition Period.
- 5.3 Prizes are subject to availability. If the prizes offered are unavailable due to circumstances beyond the Promoter's control, the Promoter reserves the right to offer an alternative prize of equal or greater value.
- 5.4 The prize is non-exchangeable, non-transferable and no cash alternative is offered.

## 6. Winners

- 6.1 The draw will be organised by Hits and Jams (the "**Organiser**").
- 6.2 The winners will be chosen randomly and in ascending order at the end of the Competition Period.
- 6.3 The winners will be notified publicly and by text by the Promoter. Each winner will need to follow the instructions in the notification message to claim the prize. The Organiser must have received all the required information, including the winner's full name, email address, telephone number and postal address, within 3 days of first notification.
- 6.4 In the event the claim for the prize is not received by the Organiser, or if the winner fails to provide all required information including a full name and valid address for the delivery of the prize within 3 days of first notification, the Promoter reserves the right to withdraw their prize entitlement and select an alternative winner.
- 6.5 The prize will be available for collection within 3 days from the date of the Organiser verifying the winner and receiving the winner's prize acceptance and all information required under 6.2 above.
- 6.6 No responsibility will be taken by the Promoter if a winner is not able to collect a prize for any reason and howsoever arising.
- 6.7 The decision of the Promoter regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.
- 6.8 The winners agree to the use of their name and disclosure of town or Region of residence and will co-operate with any other reasonable requests by the Promoter relating to any postwinning publicity.

### 7. Limitation of liability

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for

any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

- 9.3 These terms and conditions are governed by the law of the Co-operative Republic of Guyana. If any entrants to this promotion wish to take court proceedings, then they must do this within the courts in the Co-operative Republic of Guyana.
